

Residency Application Process Overview





2022 Match | Important Dates

June 24	Obtain your ERAS Token in the ERAS Support Services section of ECFMG's OASIS
July 1	AUC Deadline to Request MSPE Letter for 2022 Match for first-time applicants
Aug 13-20	MSPE Letters are sent to students to review for factual errors
Aug 23-Sept 21	MSPE Letters are uploaded by OCA to ECFMG/ERAS
Aug 27	Target Date to take OET to have results by Sept 29
Aug 31	Target Date to take Step 2 CK to have score by Sept 29
Sept 1-29	Apply to programs via ERAS
Sept 14	Deadline to register with ERAS in order to have the Medical School Transcript uploaded to ECFMG/ERAS by AUC Registrar
Sept 15	Register with NRMP
Sept 21	Deadline to upload supporting documents so they are available on Sept 29
Sept 29	MSPE Letters are released to programs; programs can access applications
Dec	Take OET on or before the last available test date in Dec
Dec 1	Last day to take CSA for your clinical skills attestation to be processed by Dec 15
Dec 15	Deadline for applicants to submit ECFMG Pathway Application
Jan 15	Deadline for AUC Registrar to submit CS Attestation Form to ECFMG
Feb 1	Students can submit their Rank Order List Certification
Mar 2	Deadline for Match Registration and Rank Order List Certification
Mar 14	Students find out IF they matched
Mar 18	Students find WHERE they matched



Researching Programs | June - August

Consider your personality and short and long term goals.

List programs in which you're interested and narrow down by researching program websites

Look for programs that have taken IMGs and match USMLE requirements, if applicable

Applying to Programs | September 1 – 29

Review online presence to ensure it promotes an image of professional and mature physicians

In a typical application year, most students will apply to 100-200 programs

Use Residency Fee
Calculator to
estimate costs of
applying
(150 programs cost
approx. \$3k)

Goal is to get at least 10 interviews

Budget \$8k for applications and interview costs

- AAMC lists range of \$1,000 - \$7,300
- Review <u>Travel Tips</u> to save money



Interviewing with Programs | October - February

Try to avoid interviewing at your top choice program until you have completed at least one interview

Nervous and less confident early on, so use programs in which you are not as interested in to improve skills

No consensus if better to interview early or late in season

Early because programs are fresh and excited about meeting applicants.

Late so you'll be more memorable.

Remember: Program Coordinator organizes the interview schedule and is closest to the Program Director – be nice!



Residency Application Supporting Documents

- ✓ <u>Letters of Recommendation (LoRs)</u> provided by student/letter writer
- ✓ <u>USMLE Transcript</u> provided by student
- ✓ <u>Personal Statement</u> provided by student
- ✓ <u>ERAS Application (CV)</u> provided by student
- ✓ Photograph provided by student
- ✓ <u>ECFMG Status Report</u>
- ✓ <u>Medical School Transcript</u> provided by Registrar
- ✓ MSPE Letter provided by OCA (See Sample) (Submit request by July 1, 2021)

ECFMG Supporting Documents Overview



Letter of Recommendation (LOR)

Need at least one LOR in the specialty or specialties in which you apply

No limit to number of LORs students can submit to ERAS, but can only assign four to each program

Letter writers are the only individuals who can upload an LOR via AAMC's portal if the student has waived his or her right to view the LOR



Match Strategy

- Competitive for specialty (<u>Charting Outcomes in the Match for IMGs</u>)
- Parallel Specialty if not competitive for preferred specialty
- Apply to sites where you rotated
- Strong LORs (at least in preferred specialty)
- Apply to sites in your home state
 - Mention you are from the area in personal statement
- Apply broadly
 - Different geographic regions, different types of programs (community/university)
- Consider going for the 2023 Match and opting into the 80-week program if you won't have an LOR in your preferred specialty or CK completed available for programs to view on Sept. 29

Residency Interview Questions | Examples

Start Practicing Now!

- ✓ Tell me about yourself
- ✓ Why are you interested in this program?
- ✓ What challenges will our specialty face in the next 10 years?
- ✓ Why did you choose your specialty?
- ✓ What are your long-term goals?
- ✓ Why do you want to be a physician?
- ✓ How do you handle stress?

ECFMG Pathways

CS cancellation resulted in ECFMG creating new requirements to satisfy the clinical and communication skills required for ECFMG Certification

- Occupational English Test (taken by student) (\$455)
 - Can be taken at a test center or online (limited availability)
 - Native English-speakers failed the exam in 2021
- Clinical Skills Attestation Form (submitted by school)
 - Students must pass Kaplan Clinical Skills Assessment
 - AUC will use exam to complete Clinical Skills Attestation form, which is uploaded to ECFMG
- Apply for a Pathway (\$900)
 - Failure to apply to the Pathway will result in withdrawal from NRMP and were not able to participate in the Main Match or SOAP
