



RETURN TO CAMPUS CHECKLIST

BEFORE ARRIVING IN THE UK:

- Proof of negative test 3 days before travel
- Book and pay for a travel test package on day 2 and 8 of quarantine. This needs to be purchased from Gov website with test reference numbers added on the passenger locator form (https://quarantinehotels.ctmportal.co.uk/Quarantine/Home.aspx)
- Complete a Passenger Locator Form 48 hours before travel (Note that the address should reflect the accommodation you have booked. Tramshed address: 160 Corporation Street, Preston, Lancashire, PR1 2UQ, Sanctuary Moor Lane Halls 140-142 Moor Lane Preston, Lancashire, PR1 1JW)
- Attend "Return to Campus COVID-19 Training" on Blackboard and upon completion send Mandatory Covid Training Certificate to: crankin@uclan.ac.uk
- Take "Personal Evaluation" (https://www.uclan.ac.uk/students/covid-assessment)
- Book train ticket through Trainline App for travel to Preston if required (Trainline)
- Register with UCLan Medical Centre (https://www.uclan.ac.uk/students/campus-life/health.php)
- Keep up-to-date with travel advice (https://www.gov.uk/guidance/how-to-quarantine-when-you-arrive-in-england)

WHEN YOU ARRIVE IN THE UK:

- Pre book student testing dates 3 days apart (https://www.eventbrite.co.uk/e/covid-19-test-booking-preston-campus-tickets-141006914477)
- Collect Student ID Card from Library
